Airline tickets will be distributed at the airport directly to all passengers on the day of the departure or sent to all passengers within one week prior to departure, providing the passenger's final payment has been processed. All checks must be made payable, in U.S. dollars, to THE RENAISSANCE GROUP. A COMPLETE PAYMENT FOR EACH TRAVELING PASSENGER MUST BE RECEIVED AT LEAST 60 DAYS PRIOR TO DEPARTURE. Foreign reservations are subject to additional processing time and mailing fees.
